## 8.3 To agree to transfer via cheque balance in account to Unity Trust Bank

As Barclays had been extremely difficult in transferring the funds it was agreed that the balance of funds after cheque payments be signed to Unity so that the Council could transfer its bank account to them. A cheque in the amount of £8,500 was signed payable to Antingham Parish Council's new account at Unity Trust.

A secondary cheque would be signed for residual monies in due course and the Barclays accounts would then be closed.

The Clerk would keep all Councillors informed of progress. EP

9. To authorise expenditure for Antingham Village Sign (£1,500 budget)
The signs had been removed for assessment and they were in extremely
poor condition, the wood had deteriorated quickly and one plaque had
broken in half. A quotation had been sourced with a specialist company
who would cast the signs in polyurethane - as this is extremely specialist
work Financial Orders were suspended to enable the work to be
completed.

It was resolved that Sign of the Times be appointed at a cost of £1,450 plus VAT and carriage. The Clerk would arrange.

10. To Receive Reports from Councillors and items for the next Agenda *Graham Pinner* - informed that the Village Hall had applied for funding for the upgrading of the external walls to the Offshore Windfarm fund. There was a little way to go and questions were asked - what would happen to the Village Hall on dissolution and how the energy efficiency would be measured?

**James Tulley** - reported that the ruins of St Margaret's had received a tidy up with the foliage removed and a new fence would be installed around the perimeter. The Christmas services were well attended.
